## **VOMC, Inc. 2023 POOL and TENNIS COURT RULES**

- The pool is open from the Saturday (5/27) prior to Memorial Day through Labor Day (9/4), weather permitting.
  - o Daily Hours: Sun-Sat 11:00 am to 8:00 pm
  - O School Days: Mon-Fri 4:30 pm to 8:00 pm (between August 10 Sep 1)
- Only Village Of Mount Carmel, Inc. Members and Associate Members will be admitted to the pool.
   Verification of membership will be performed daily by the lifeguards. Any non-members or unpaid members attempting to enter will be considered trespassing on private property and will be asked to leave immediately.
- DO NOT enter if you have a cough, fever, or other symptoms of illness.
- Children under 12 must be accompanied at all times by a responsible adult 18 or older.
- Club Members may bring a maximum of six guests per day and must accompany them to the pool.
- No smoking or vaping anywhere on the facilities
- No pets are allowed in the pool area or on the tennis courts.
- No food or drinks are allowed inside the pools or around the edges of the pools.
- No glass containers anywhere. Use of alcoholic beverages shall be in compliance with the laws of the State of Indiana.
- Nonswimmers must be accompanied at all times by a responsible adult 18 or older.
- No large flotation devices.
- The baby pool is for the use of children 5 and under. These children are <u>not</u> the responsibility of the lifeguards, but of the accompanying responsible adult 18 or older. <u>These children shall not be left unattended</u>.
- Children who are not potty-trained shall wear diapers and tight fitting plastic pants.
- There will be a 15-minute break every hour for the lifeguards. Everyone under the age of eighteen (18) shall clear the pool during this time. During this time, the lifeguards are not on duty and neither the Club nor the lifeguards shall be responsible for adults using the pool during the break.

- The certified lifeguards provided by C&N Pool Management Inc. are responsible for the safety of
  everyone and have the authority to discipline swimmers and any and all other persons within the pool
  facility within their best judgment.
- The pool may be closed due to emergencies, or due to poor weather conditions including lightning, for which there will be a one hour break from the last occurrence; thunder, for which there will be a half hour break from the last occurrence; and air temperature lower than 70 degrees Fahrenheit. If the poor weather conditions still exist at 6:00pm, the pool may be closed for the remainder of the day.
- Swimming lessons for Club Members may be offered outside of the normal operating hours. Call C&N
   Pool Management to determine if a lifeguard is available and other specific logistics.

## VOMC, INC. POOL PARTY PROCEDURES

- The pool is available for parties after 8pm by advance reservation. Only VOMC Inc. Members 21 years of
  age or older may make a pool party reservation. The member making the reservation must be present
  to chaperone the party and will be responsible for any damages. Parties must end by 11:00 p.m.

- C&N Pool Management Inc will determine the number of lifeguards required based on the number of guests. The renter shall pay <u>cash</u> compensation directly to the lifeguard(s) at \$20/hr. per lifeguard
- No smoking or vaping anywhere in the facilities or on the tennis courts
- Use of alcoholic beverages shall be in compliance with the laws of the State of Indiana.
- All guests shall adhere to these Pool and Tennis Court Rules
- C&N Pool Management or the VOMC, Inc. reserves the right to refuse or terminate any party in progress as deemed necessary.

## **VOMC, INC. TENNIS COURT RULES**

- Only Tennis and Pickleball players are allowed on the courts. Dogs, bicycles, roller blades, skateboards, etc. are never allowed.
- Only paid VOMC, Inc. Members may use the courts. (All of our facilities are **Private**)
- You may bring up to 3 guests with you.
- Nonmembers are <u>not entitled</u> to use the courts at any other time and may be prosecuted for trespassing on
   Private Property
- No black-soled tennis shoes or hard-soled shoes please as they will permanently mark the surface
- A time limit of one hour shall be honored when other Members are waiting to use the courts
- No smoking or vaping on or within 25 feet of the courts.
- No glass containers.
- The VOMC, Inc. is not responsible for any injuries sustained while using the courts
- Please report any form of vandalism anywhere on the grounds or in the neighborhood to the Carmel Police at 317-571-2580. Take cell phone video, if possible, of persons and license plates for evidence.
